

2011 PCCYFS ANNUAL CONFERENCE

PRESENTER BENEFITS, TERMS AND CONDITIONS

The PCCYFS Conference Planning Workgroup appreciates your willingness to share your expertise by presenting at our 2011 Annual Spring Conference. Sharing your experience and knowledge at a state-wide conference often leads to an increased awareness of your organization's mission and provides a wonderful opportunity to network with professionals who influence the lives of children, youth and families throughout the Commonwealth of Pennsylvania.

In exchange for sharing your expertise, you may expect the following:

- The primary presenter will receive:
 - Complementary admission the day of their presentation, including continental breakfast, mid-morning and afternoon break refreshments, lunch and attendance at the Wednesday evening special event.
 - A 50% discount off the one-day registration rate for an additional conference day.
- A co-presenter will receive:
 - Complementary admission the day of their presentation, including continental breakfast, mid-morning and afternoon break refreshments, lunch and attendance at the Wednesday evening special event.
 - A 25% discount off the one-day registration rate for an additional conference day.
- Group/panel presenters (3 or more presenters) will receive a \$50 discount off the registration rate or as determined on a case-by-case basis.
- PCCYFS will arrange for a microphone, podium, flip chart with markers, screen, LCD projector and laptop computer for all workshop sessions. Requests for internet access or any other audio/visual equipment (audio speakers for video, overhead projector, etc.) must be indicated on the workshop proposal form and will be considered on a case-by-case basis, depending on cost and need. *Note: Any video presentation must be digital (on a DVD or USB flash drive), not on a videotape.*
- Requests for remuneration must be submitted with the conference planning proposal. We ask that you exercise discretion, considering our financial limitations and desire to keep the registration fee as affordable as possible for conference registrants. Unless otherwise negotiated in advance, travel, hotel, and other expenses incurred will be the responsibility of the presenter(s).
- Workshop proposals, including all supporting information, must be **e-mailed** to PCCYFS at hbgooffice@pccyfs.org (or otherwise submitted **electronically**) by **August 16, 2010**. The Conference Planning Workgroup will notify selected presenters by September 30, 2010.
- Should your workshop be selected for the 2011 Annual Conference, you must provide your PowerPoint presentation (if using) and one copy of all handouts to PCCYFS by **January 31, 2011**. Materials must be **e-mailed** (hbgooffice@pccyfs.org) or otherwise provided **electronically** for inclusion in the compilation of workshop handout materials that will be made available to conference attendees and for preloading on the computers provided for each breakout room.
- Solicitation or promotion of your own business during your presentation is **not** permitted. However, you may make materials available to session participants on the table provided in the back of the room. We appreciate your adherence to this non-solicitation/promotion policy.
