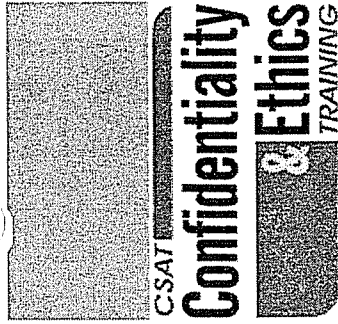


Training Objectives

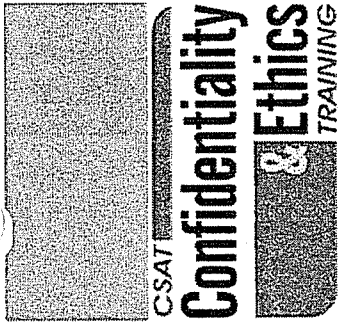
